Our Services

Through 18 programs, Greenleaf Family Center is privileged to serve nearly 8,000 individuals annually who face the challenges of daily living and personal crises that arise from a variety of problems, including personal adjustment, marital problems, teenage parenting, alcohol and drug addictions, financial instability and school adjustment. Services include:

Counseling - family and individual counseling is available for children, youth and adults on a variety of issues. In 2010, **2,297** individuals were served through **8,027** hours of counseling. Greenleaf also offers group counseling to address an array of problem areas such as Anger Management for adults and adolescents. Our Anger Management program served **196** individuals in 2010.



Tri-County Employee Assistance Program - provides individual, marital and family counseling for employees and their dependents in addition to workforce management and crisis support. Tri-County covers the lives of **12,414** employees. With an average of 2.5 dependents per employee, this program covers almost **31,035** people in our community.

Community Services for the Deaf - offers interpreters, case management, ADA information and referrals, specialized equipment loans, in-service training, advocacy and emergency services to deaf and hard-of-hearing individuals and their families. CSD is the only program of its kind in Summit County and serves Portage, Holmes, Wayne and Medina Counties as well. In 2010, Greenleaf provided assistance to **1,873** individuals and completed **3,156** hours of interpreting services.

Family Support Programs - Parenting Classes for parents who have difficulty providing consistent and appropriate direction to their children. The **Teenage Parent Program** provides case management services to pregnant and parenting teens, as well as, bi-monthly support groups. **SPARK** is a kindergarten readiness program for 3 and 4 year olds who will be attending four local Akron public elementary schools. The **Teen Pregnancy Prevention Program** operates in four different locations within Summit County. In 2010, **779** individuals were supported through **4,311** hours of service.



Program Highlight:

School Based Services - a variety of research-based and intervention programs that work to discourage aggression, bullying and violence in area elementary and middle schools. We also provide behavioral health and anger management group services to students at Akron's *Alternative and Digital Academies* and *Coventry's Lakeview and Turkeyfoot Elementary Schools*. In 2010, **1,099** individuals were served through our school based services.

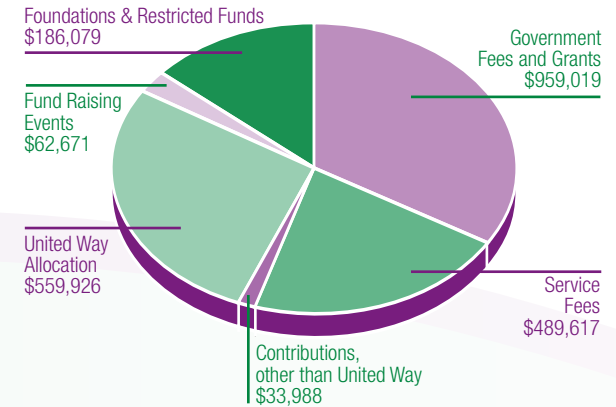


Youth Programming - Families in Action, a program for teens and their parents and Teens on Task, juvenile diversion programming for at-risk teens and their families to deter them from future or on-going court involvement. In 2010, **151** individuals were served.

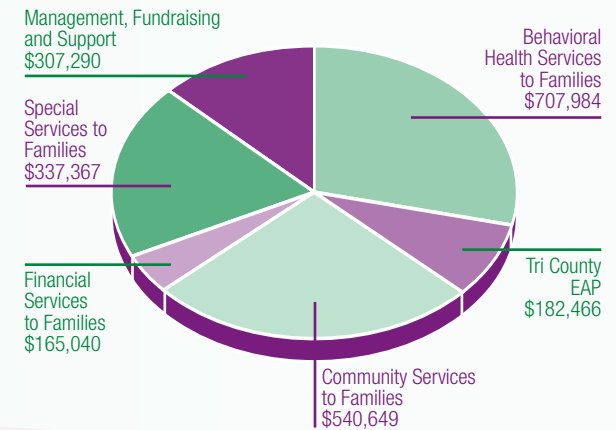
Financial Services for Families -

helps families move toward financial self-sufficiency and retain employment through the *Automobile Loan Program, Credit Counseling Services, Credit Happens Workshops, Automotive Repair Program, and Bankruptcy Counseling*. A total of **971** individuals were assisted in 2010 through these programs.
